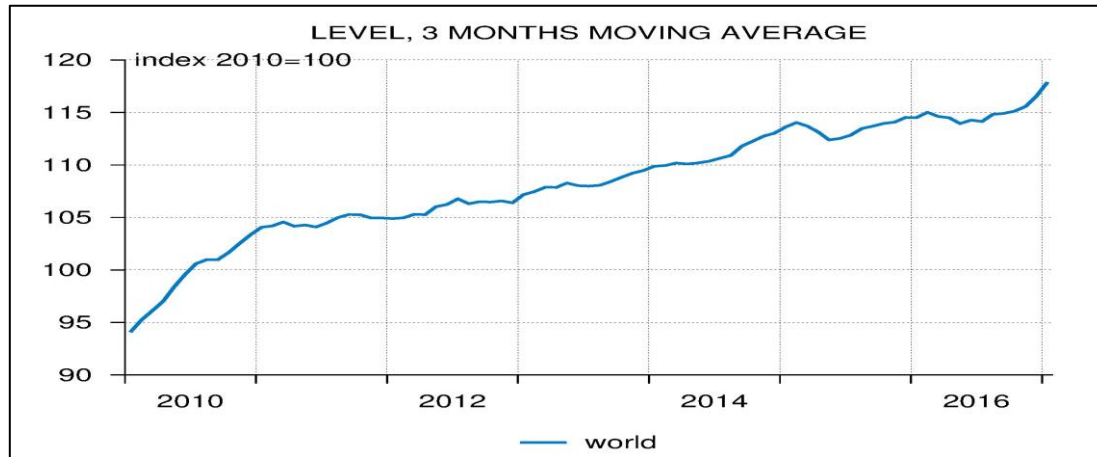

Developments in global international trade and industrial production January 2017:

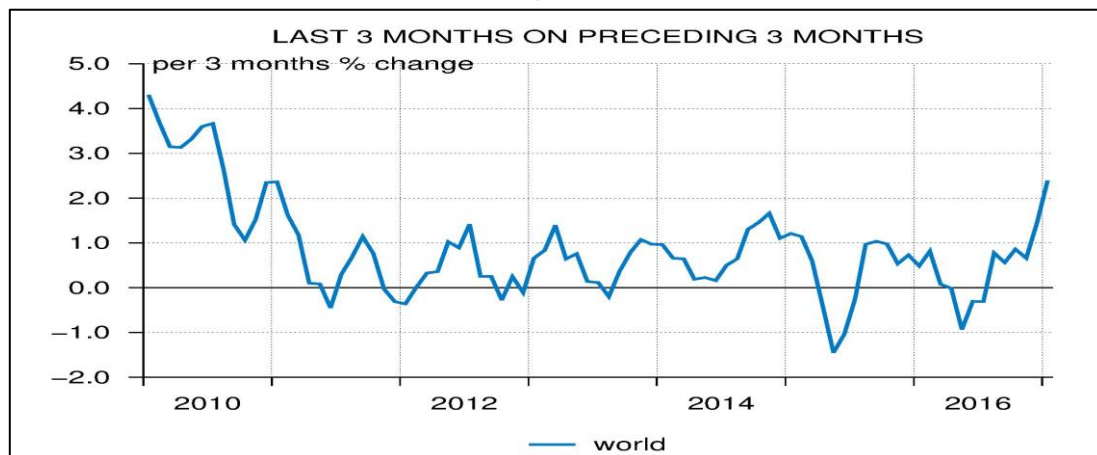
- World trade was stagnant month-on-month (growth was 0.9% in December, initial estimate 0.5%).
- World trade momentum was 2.4% (non-annualised; 1.4% in December, initial estimate 1.1%).
- World industrial production grew 0.2% month-on-month (0.1% in December, initial estimate 0.0%).
- World industrial production momentum was 1.3% (non-annualised; 1.1% in December, unchanged from the initial estimate).

The next release of the CPB World Trade Monitor is scheduled tentatively for 25 April 2017.

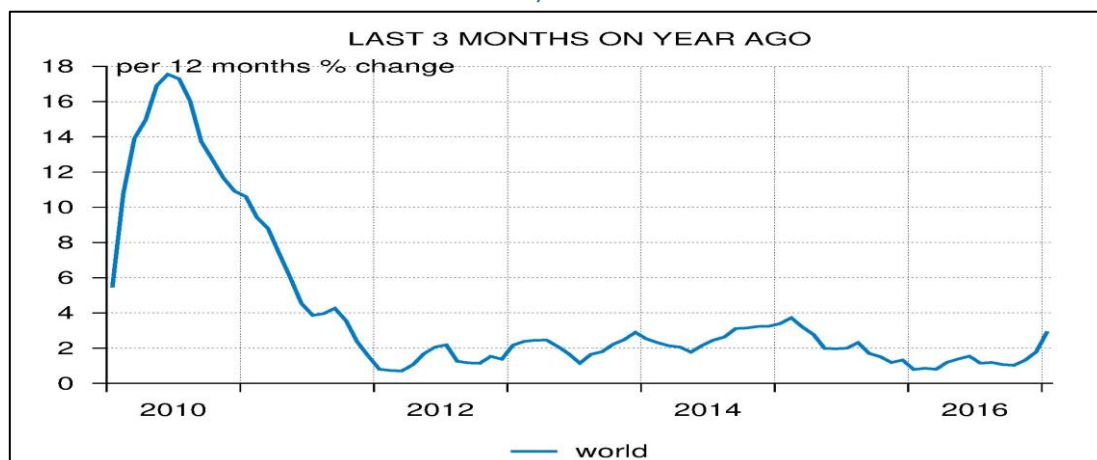
WORLD MERCHANDISE TRADE VOLUME, CHART 1

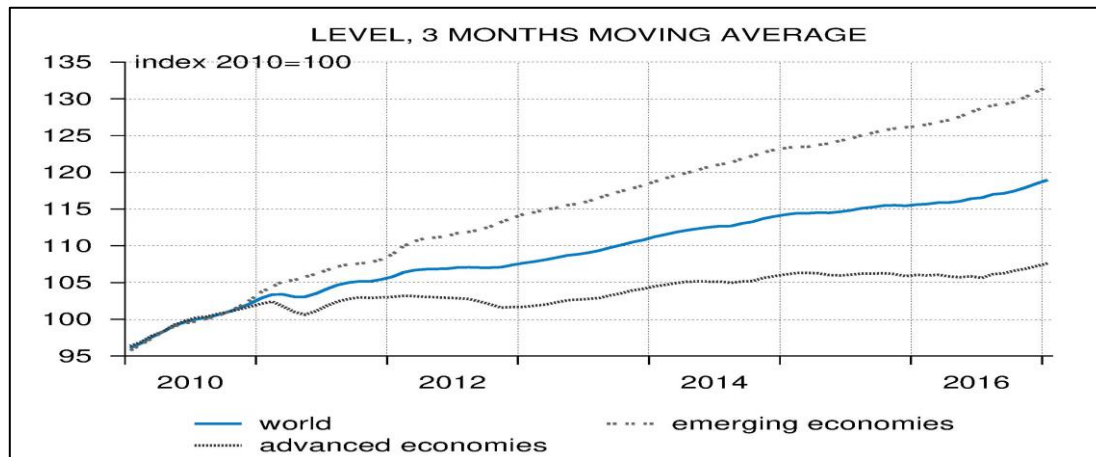

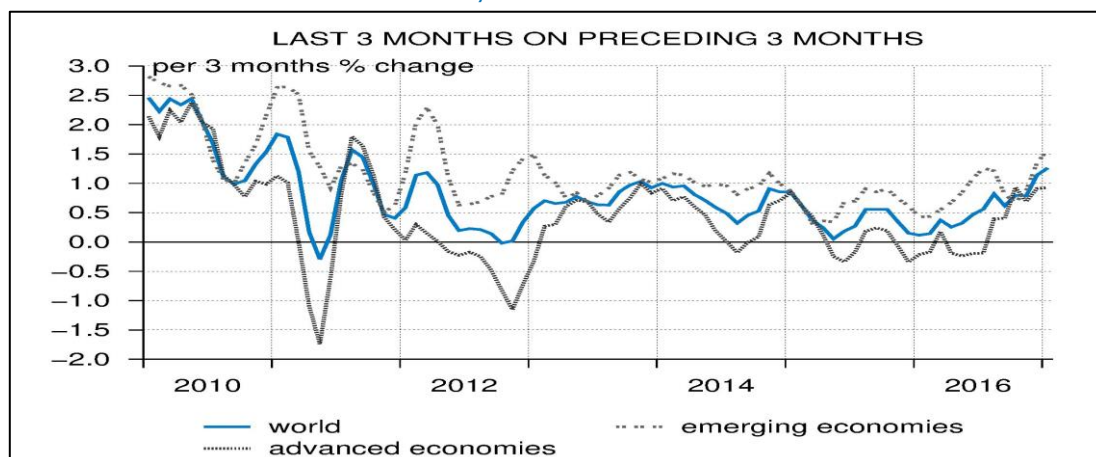

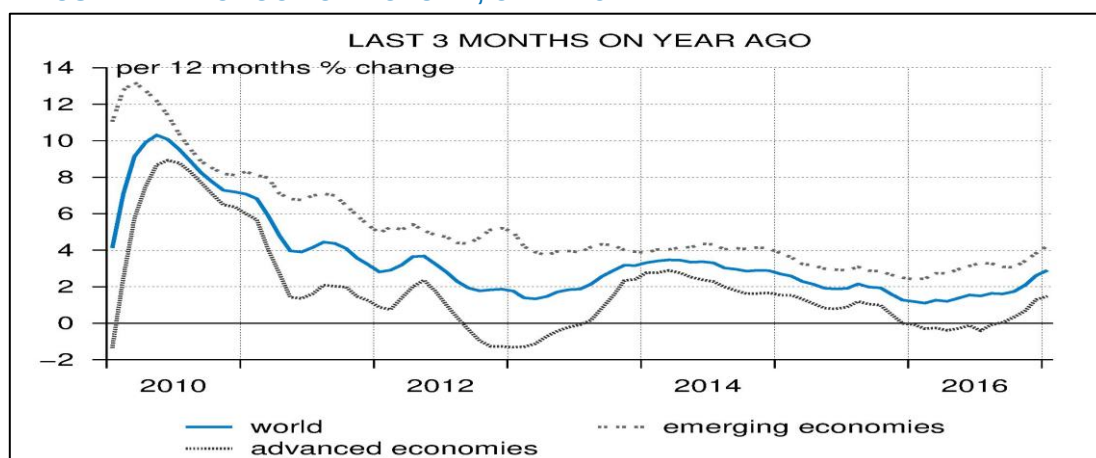
